Fee Schedule

Upon submitting an Application for a Business License, you will also be required to submit a fee to the City based on you *Estimated Gross Receipts* and the type of business that you own. Some businesses, however, are covered by a flat rate. The fee schedule for all businesses appears below.

How to Obtain a Business License In the City of Laguna Beach

WELCOME TO THE CITY OF LAGUNA BEACH

GENERAL INFORMATION

All businesses operating in the City of Laguna Beach are required to obtain a Business License Tax Certificate with the City. This includes home-based businesses. The purpose of the Business Tax is to raise revenue for the City's General Fund, which provides Police and Fire protection, street maintenance, parks, and other city services while ensuring that all businesses operate in compliance with the Municipal Code. *If you are a non-profit business and provide letters of tax exemption, you are exempt from paying the Business License tax fee. However, you are still subject to the Zoning and filing fees.*

This brochure will walk you through the process of obtaining a City Business License.

STEP ONE OBTAIN A FEDERAL TAX ID NUMBER

All businesses applying for a City Business License with the City of Laguna Beach, including Partnerships, may wish to obtain a Federal Tax ID Number. Obtaining this identification number is quite simple and can be completed over the phone by calling the Internal Revenue Service at 1-800-829-1040.

STEP TWO OBTAIN A D.B.A. OR FICTITIOUS BUSINESS NAME STATEMENT

If you will be using a business name other than your own first and last name, you will need to obtain a D.B.A. or Fictitious Business Name Statement from

the Orange County Clerk in Santa Ana. The Clerk can be reached by phone at (714) 834-3005 and is located at 630 N. Broadway, Building 12, Room 101, Santa Ana, California 92701.

Before you file the DBA, you will need to ensure that the name you have chosen has not already been taken. It is your responsibility to ensure the name is available, as the County will process any name you give them. Therefore, to ensure that your name is available, you will need to have a name search done. This can be done in several ways: 1) You can go to the Orange County Clerk's Office and search through the records yourself; 2) You can have the County do the name search for an additional \$6.00; or 3) You can have a local newspaper do it for you. **Some newspapers will do the name search, help you fill out the form, file your DBA, and publish it for a package price. The Laguna Beach Coast Line Pilot is the most local paper to offer this service and can be reached at (949) 494-4321.**

Within 30 days of filing for your DBA, you must publish it in a legally adjudicated newspaper. As long as the paper is in the County and is legally adjudicated, it doesn't matter which one you use. There are over 30 newspapers that are legally qualified to do this for you in Orange County.

STEP THREE OBTAIN THE APPROPRIATE STATE PERMIT FOR YOUR BUSINESS

If your new business is *retail, wholesale, temporary sales, or leases merchandise*, you will need to obtain a **California Seller's Permit** from the California State Board of Equalization. The Board can be reached locally by phone at (949) 440-3473 and is located at 16715 Von Karman Avenue, Suite 200, Irvine, CA 92606-4918

If you are or plan to become a *real estate agent*, conducting business within the City of Laguna Beach, you are required to obtain a City business license and

you must obtain a Real Estate License from the California Department of Real Estate. The department can be reached at (916) 227-0931 and is located at 2201 Broadway, Sacramento, California 95818-2500.

If you are or plan to become a *general or sub contractor*, doing business in the City of Laguna Beach, you are required to obtain a City business license and obtain a **State Contractor's License** from the State Contractor's Bureau. You can contact the Contractor's Bureau by phone at (916) 255-3900 and is located at 9821 Business Park Drive, Sacramento, California 95827. These license numbers are required on the City Business License Application.

STEP FOUR FILE A BUSINESS LICENSE APPLICATION AT CITY HALL

After all of the previous applicable steps have been completed, you may visit the Cashier Counter at Laguna Beach City Hall, 505 Forest Avenue, and file an **Application for a Business License Tax Certificate**. Along with the Business License application you will need to complete a number of other forms based on the location and nature of your business.

Commercial locations will need to file an **Emergency Notification Index Card** for the Laguna Beach Police Department when you file your business license application. This card allows the Police Department to contact you or a trusted employee in the case of an emergency at or near your business. Also, you will need to file a **Hazardous Materials Disclosure Form** for the Orange County Fire Authority.

If you will be operating your business from your home, you will need to complete a **Certificate of Use for Home Occupation Form** with your B/L Application. Businesses in commercial locations are required to have zoning approval. This can be
