The requested monthly Investment Report follows. I verify that the investment portfolio is in conformity with California laws and the Treasurer's Investment Policy which is approved annually by the City Council.

The policy states that there is a 2% limit on any one issuer of Corporate Notes at the time of purchase. At the time of purchase no single issuer exceeded 2%. At October 31, 2019 two issuers exceeded 2%.

The Treasurer's cash management program provides sufficient liquidity to meet expenditure requirements for the next six months.
